Term Membership 1 Year

- A 1 Year Individual Term Member shall be only one person who is entitled for the full rights and privileges in accessing all PHGC facilities for their personal purpose.
- 1 year Term Membership is issued for a period of not more than one year.

Term Membership 3 Years

- A 3 Year Individual Term Member shall be only one person who is entitled for the full rights and privileges in accessing all Golf Club's facilities for their personal purpose.
- 3 Year Term Membership is issued for a period of not more than three years.

Corporate or Couples Membership 1 Year

- Corporate or Couples Membership shall allow the applicant to nominate 2 fixed names, who will have the rights and privileges regarding access to PHGC facilities for their personal purpose.
- A corporate membership may be held by a Corporation, Limited Company or Partnership which has been approved to become Corporate Members. A Corporation shall nominate a maximum of two (2) of its directors, executive officers or partners to be Corporate Members as stipulated in the application form.
- A Corporate Membership can be transferred only if the validity is not less than six (6) months and is subject to a transfer fee of US \$1,000.
- A couples membership will require proof of marriage, joint surname I.D. or other acknowledgement of partnership.

Junior Members 1 Year

- A 1 Year Junior Member shall be only one person who is entitled for the full rights and privileges in accessing all PHGC facilities for their personal purpose.
- Junior Membership is limited to young Golfers 18 years and below. Upon the Junior Golfers 19th birthday they will be subject to the adult category of membership.
- Junior Golfers below the age of 13 will require to be accompanied by an adult when using the clubs facilities.

Country Club

- A family membership constitutes 2 adults and 2 children (under 16 years of age), additional adults and/or children are chargeable.
- Each member may bring a maximum of up to 3 guests to PHCC on any day at the published rate
- Member's children under the age of 6 years may use the pool area accompanied by no more than 2 nannies / helpers.
- Not applicable to Junior Membership.

GENERAL



- 1 Acceptance of membership is at the discretion of PHGC management and subject to approval of the Golf Club Director.
- 2 A handicap is required for membership; Man/Boy 28 and Lady/Girl 36. A recent handicap certificate is required, or a letter from a previous / current club or a PGA Professional to confirm the applicants' current ability or handicap. Alternatively, recent scorecards to reflect applicants' ability.
- 3 The membership fee is subject to change which may be without prior notice, although the club will always aim to communicate any changes in advance to provide notice. All applications must be accompanied by payment and any deposit stipulated by PHGC. The fee is non-refundable and the membership is not transferable without approval of the Golf Director for certain categories only.
- 4 A copy of the applicant(s) Identity Card / Passport and two passport sized photos are required.
- 5 A member shall be entitled to use the Clubhouse, Golf course and facilities at any time during opening hours and is advised to show membership identity card to receive discounts.
- 6 A member shall not be required to pay green fees but a caddie fee will apply.
- 7 Any person(s) may be introduced by a member as a guest to PHGC who will then be entitled to use all the facilities of the club. A member introducing a guest to play shall sign the details of their guest and shall be responsible for any debt to PHGC incurred by their guest.
- 8 No person who has been expelled from PHGC or who has been excluded from admission may be introduced as a guest to PHGC. The conduct and behavior of the guest(s) shall be the responsibility of the member introducing the said guest(s).
- 9 Applicants for a Term / Corporate / Couples membership shall be at least nineteen (19) years of age.
- 10 All applications for admission to membership shall be made in the form prescribed by PHGC. The form shall be signed by the applicant with the name, address (both residence and office), occupation and designation of office (if any) shall be stated in the application form.
- 11 Caddies & Golf Cart Policy;
 - * Members are required to abide by club rules which is to pay a mandatory caddie fee upon check-in for their game and play their round of Golf with a caddie supplied by PHGC or as booked by the members; the preferred choice of caddies is subject to availability and on a first come first served basis. Caddies not registered employees of PHGC will not be permitted to caddie in the Golf course.
 - * Members are advised that the standard gratuity for the caddies following completion of a round is MMK 20,000 minimum for 18 holes and MMK 10,000 for 9 holes.
 - * PHGC has electric drive-on carts (club car) available for rent which the caddies will drive and the Golfers will be passenger. The club policy is 1 Golfer per cart as some areas of the Golf course are prohibited for use. On occasions when Golf cart demand is high, PHGC may approve 2 Golfers to share a cart for an increased cart fee and caddies will walk behind. No standing on the back or hanging on the side for safety reasons.
 - * Should Members wish to bring their privately owned Golf cart to the Golf course for their own use they will be required to pay a nominal fee to PHGC each time, which will be 50% of the cart fee.
- 12 PHGC may create new and or retire categories of membership from time to time as it deems fit.
